- () Yes I agree to the fullest extent of the law hereby release, waive, discharge and agree not to sue or engage in any legal action against Reef Divers, its parent company, related entities, employees, agents, directors, owners, officers and assigns (hereinafter referred to collectively as "Reef Divers") from all responsibility and legal liability to me, my personal representatives, assigns, heirs and next of kin, for any and all loss or damage and any demands on account of injury to my person or property or resulting in or from my death, now and forever, arising out of or related participation and/or instruction in said course, snorkeling, scuba diving, recreational and technical rebreather diving and/or Watersports activities including vehicle and/or vessel transportation ("Watersports Activities"), whether caused by the negligence of Reef Divers or otherwise.
- () Yes I agree that my participation in Watersports Activities is entirely voluntary and of my own free will.
- () Yes (**Scuba Diver Only**) I acknowledge that participation in scuba diving, recreational or technical rebreather activities require certification by a recognized dive training agency.
- () Yes I am aware of and I accept that Watersports Activities are potentially dangerous activities and understand the inherent risks of participating in these activities.
- () Yes I understand and agree that Watersports Activities involve physical exertion in a marine environment that will expose me to risk of injury or death from heart attack, panic, hyperventilation, hypothermia, drowning, fatigue and exhaustion, as well as from wind and weather conditions, tides, currents, waves, equipment failure, interactions with watercraft, swimmers, aquatic life, rocks, docks, pilings, buoys and other potential hazards all of which may not be visible, known or anticipated and I agree that these are all inherent risks of my chosen activity and I will not hold Reef Divers responsible if I am injured as a result of these risks during Watersports Activities. I hereby assume all risk of bodily injury, death or property damage, now and forever, arising out of or related to participation and/or instruction in said course, activities, or any other related Watersports Activities, whether foreseen or unforeseen and whether caused by the negligence of Reef Divers or otherwise.
- () Yes I affirm that I am in good mental health and physically fit for Watersports Activities, and that I am not under the influence of alcohol, nor am I under the influence of any drugs that are contradictory to safe Watersports Activities. If I am taking medication, I affirm that I have seen a physician and have approval to participate in Watersports Activities while under the influence of the medication/drugs.
- () Yes (**Scuba Diver Only**) I am aware of the dangers of breath holding while breathing compressed air when scuba diving or recreational and technical rebreather diving and will not hold Reef Divers responsible if I am injured in doing so.
- () Yes (**Scuba Diver Only**) I understand that even though I follow all the appropriate scuba diving practices, there is still some risk of sustaining decompression illness\sickness, embolism or other hyperbaric injuries, and I expressly assume these risks.
- () Yes I understand that during Watersports Activities, I will be participating in these activities in a remote site and that there will not be immediate medical and/or hyperbaric treatment available to me, and I expressly assume the risk of participation in such remote locations.

- () Yes I hereby acknowledge that injuries received may be compounded or increased by negligent rescue operations or procedures of Reef Divers and agree that this waiver and release of liability, assumption of risk and indemnity agreement extends to all acts of negligence by Reef Divers, including negligent rescue operations.
- () Yes DIVING AND WATERSPORTS RENTAL EQUIPMENT – I hereby accept any and all Watersports Activities equipment in as-is condition and will personally inspect the equipment before use and will satisfy myself that it is in good order and working condition. Reef Divers accepts no responsibility for any defect in the equipment and does not warrant that it is suitable for any particular purpose. I agree that the use of said equipment is at my own risk. I shall return the same equipment in good order and working condition and shall be financially liable for any deviations therefrom.
- () Yes I will inspect all my equipment prior to participating in Watersports Activities and will notify Reef Divers if any of my equipment is not working. I will not hold Reef Divers responsible for my failure to inspect my equipment prior to Watersports Activities.
- () Yes (**Scuba Diver Only**) I acknowledge I am diving with a dive computer and understand how to use the dive computer and have been given sufficient knowledge on how the dive computer works. I agree to stay within the limits of the dive computer and to follow recommendations the dive computer displays. I agree that at any time and for any reason that the dive computer recommends I do not dive, I will refrain from doing so for as long as the dive computer manufacturer recommends.
- () Yes I fully understand that participating in Watersports Activities is at my own risk and hereby release, indemnify, save and hold harmless Reef Divers from all claims, loss, damage, injury and liability arising from any injury, illness or death sustained by me while engaged in Watersports Activities; caused or occasioned by reason of the perils or dangers of the sea; or by reason of the act, omission, negligence or default of any other person(s) engaged in Watersports Activities; or as a consequence of illness, disease or disability which renders such person(s) unfit for Watersports Activities, and I hereby expressly assume all risks of Watersports Activities.

- () Yes I acknowledge there is absolutely no consumption of alcohol allowed before Watersports Activities.
- () Yes I acknowledge that all scuba, recreational or technical rebreather divers are responsible for pre-dive equipment checks including checking tank pressure.
- () Yes I acknowledge that all scuba, recreational or technical rebreather divers must dive with a buddy, and no solo diving is permitted. Furthermore, I agree to practice safe buddy procedures and that each buddy in the team must have the minimum required equipment including a BCD with power inflator, regulator with alternate air source (octopus, etc.), depth gauge and timing device (which can be the dive computer), mask and fins, and each use a dive computer.
- () Yes I agree to abide by the recreational no-deco dive profiles and stay at or above the recreational depth limit of 110' for computer divers and 100' for table divers as set by Reef Divers. I understand that no decompression diving is allowed/permitted unless specifically authorized for technical diving by Reef Divers.
- () Yes I agree to three (3) minute safety stops on all dives and return to boat with a minimum of 500 PSI / 50 BAR.
- () Yes I agree to follow all dive computer warnings and comply with all stops (deco and safety stops) the dive computer displays while I am diving.
- () Yes I acknowledge that should my personal dive computer fail or be locked in "no dive mode" due to equipment failure or a violation of my dive computer's no deco profiles, Reef Divers must and will default to the computer manufacturers' guidelines and specifications. I understand that Reef Divers cannot issue subsequent equipment in lieu of the locked-out computer nor make dive profile recommendations until the personal dive computer is cleared or returns to safe dive mode.
- () Yes In compliance with Cayman Island law, I understand that no gloves are allowed in the marine environment, and I agree to maintain a hands-off policy towards all marine life and corals which includes no feeding, harassing or molesting. No camera, equipment or hand is allowed to contact the reef.
- () Yes I agree to abide by the 18-hour minimum dive/fly policy. Flying out on a morning flight prohibits diving the afternoon on the day before departure.
- () Yes I acknowledge that willfully violating Reef Divers rules and regulations may cause forfeiture of any and all dives, and/or use of camera equipment, without a refund.
- () Yes Reef Divers reserves the right, at its sole discretion, to require a diver to perform a checkout dive prior to an unsupervised dive to ensure safe diving practices.
- () Yes Any diver wishing to perform Rebreather/Technical dives may, at the sole discretion of Reef Divers, be required to perform a Rebreather/Technical skills theoretical examination and a checkout dive with a Rebreather/Technical instructor prior to conducting unsupervised diving.

- () Yes I affirm that I have completed training and I am certified by a recognized oxygen enriched air (EANx/Nitrox) training organization and have presented a certification card as evidence of my successful completion of said training.
- () Yes I affirm that I understand how to operate my personal dive computer while scuba diving with oxygen enriched air (EANx/Nitrox).
- () Yes I hereby affirm that I thoroughly understand the inherent hazards of scuba diving, and the particular hazards of scuba diving with oxygen enriched air (EANx/Nitrox).
- () Yes I understand that diving with oxygen enriched air (EANx/Nitrox) involves certain inherent risks of oxygen toxicity and/or improper mixtures of breathing gas. Also, I understand the usual inherent risks of scuba diving; including but not limited to decompression illness/sickness, air embolism, drowning, or other injuries may occur and may require treatment in a hyperbaric chamber. I understand that open water diving trips, which are necessary for training, certification or for my own recreation may be conducted at a site that is remote, either by time or distance or both, from such hyperbaric chambers. I still choose to proceed with such instructional or recreational dives despite the absence of a hyperbaric chamber in close proximity to the dive site.
- () Yes I agree to personally analyze the oxygen enriched air (EANx/Nitrox) in the scuba cylinders(s) I plan to dive with. I also agree to record all pertinent information on the Nitrox Log Form which will be issued to me by Reef Divers.
- () Yes I hereby release from any legal liability Reef Divers, all recognized training associations or companies, and their owners, officers, directors, employees, agents, assigns, as well as any other manufacturer/distributor of the EANx/Nitrox generation system from any and all claims, loss, damage, injury and liability arising from any injury, illness or death sustained by me or to any persons or property resulting from the selection, installation, maintenance, adjustment or use of this equipment and/or the oxygen enriched air (EANx/Nitrox) it produces, and of any claim based upon negligence, breach of warranty, contract or any other legal theory, personally accepting myself the full responsibility for such damage, injury or death which may result from using oxygen enriched air (EANx/Nitrox).
- () Yes On behalf of me, my heirs, executors, administrators, assigns and my estate, I hereby indemnify and release, waive, discharge, hold and save harmless, relinquish any action or causes of action, which may arise for my heirs, executors, administrators, assigns and my estate and agree that under no circumstance will I or my heirs, executors, administrators, assigns or my estate prosecute or present any claim for personal injury, property damage or wrongful death against Reef Divers, all recognized training associations or companies, and their owners, officers, directors, employees, agents, assigns, as well as any other manufacturers and distributors of an oxygen enriched air (EANx/Nitrox) generation system for any cause of action, whether the same shall arise by the negligence of any of said persons, or otherwise. - () Yes I am certified by a recognized Rebreather/Technical training organization on the specific rebreather unit I will be diving and have presented a certification card as evidence of my successful completion of said training.
- () Yes I am certified by a recognized Rebreather/Technical dive training organization on the specific type of diving I will be engaging in and have presented a certification card as evidence of my successful completion of said training.
- () Yes I acknowledge that all Rebreather/Technical dives will be conducted in compliance with the accepted standards currently in use within the community of Rebreather/Technical certification agencies.
- () Yes I agree that I must dive with a buddy that is also using a closed-circuit rebreather unit. I further affirm that both my buddy and I are familiar with each other's closed-circuit rebreather unit.
- () Yes I affirm that I have and will dive with a redundant gas tracking system which will include either a redundant dive computer or analog dive tables that apply to my dive plan.
- () Yes I agree to personally analyze my scuba cylinders and confirm that I will have sufficient oxygen and diluent required to complete my planned dive(s) with sufficient reserves in the event that my ascent is delayed.
- () Yes I agree to record all pertinent information on the Rebreather/Technical Log Form which will be issued to me by Reef Divers.
- () Yes I understand that prior to entering the water the following will be conducted;
 - () Yes Confirmation of sufficient Scrubber/Sorb material life remaining in my rebreather system to complete my planned dive(s) with sufficient reserves in the event that my ascent is delayed.
 - () Yes Confirmation that I have sufficient amounts of bailout gas and reserves to dive my planned dive(s) plan safely with sufficient reserves in the event that my ascent is delayed.
 - () Yes A positive check of my rebreather loop maintaining a PPO₂ of at least 0.7 for three minutes.
 - () Yes All valves will be OPEN including all rebreather rig-gas as well as bailout gas.
 - () Yes Confirmation of my electronics package is both functioning and that there will be sufficient battery life to complete my planned dive(s) with sufficient reserves in the event that my ascent is delayed.
 - () Yes All cell reading must agree to within 0.05 PP0₂.
- () Yes I acknowledge that I am required to enter the water with sufficient consumable quantities (scrubber, oxygen, and diluent) to perform 150% of their planned run time. Example: If a dive is planned for a run time of 60 minutes, a minimum of 90 minutes of closed-circuit life support capacity must be available.
- () Yes I agree to perform a bubble check and a current limiting check at approximately 20 feet / 6 meters and will not continue my dive with either observable gas leaks or cells that will not read a minimum of 1.5 PP0₂ during the current limiting check.

- () Yes I agree to ascend from a 20 feet / 6-meter safety stop with a loop PPO₂ that will result in a loop PPO₂ of not less than 0.7 upon surfacing.
- () Yes I agree that I will immediately end my dive and make a controlled ascent to the surface with my buddy if I feel uncomfortable with the functioning and/or performance of my rebreather unit. I will immediately go to my open-circuit bailout if I feel uncomfortable with my own or my buddies diving abilities and/or diving conditions are worse than those for which have been trained, have the experience for or I am comfortable diving.
- () Yes I acknowledge that all dives will be done with sufficient open-circuit bailout gas to make a return to the anchor line, a normal ascent and to perform any safety stops that may be necessary. In addition to real time computer measurement of decompression status with redundant systems in place, I will carry and can demonstrate the use of printed bailout tables if required, including volume of open-circuit gas required for all dives contemplated. All dives will be done with bailout gas that is breathable at the surface (NO HYPOXIC MIXES). You are strongly encouraged to use Nitrox or mixes containing helium for bailout that result in a PP0₂ in the bailout gas that ranges between 1.2 and 1.6 at the planned deepest portion of your dive.
- () Yes If I become distressed at the surface, I will immediately switch to open-circuit bailout, drop any trim weights, if possible, and inflate my BC for permanent floatation assistance as a form of self-rescue.
- () Yes I understand, and I am fully aware, that there are many inherent risks and hazards associated with using any closed-circuit rebreather. I understand that no piece of equipment is foolproof, and while diving a closed-circuit rebreather I will or may be exposed to a number of hazards, including, but not limited to: (a) the risks of equipment malfunction or failure, including that which may result from the design, assembly, or manufacturer of the closed-circuit rebreather; (b) risk caused by lack of or inadequate instruction or warning; (c) risks arising from improper and/or negligent operation and/or maintenance of any closed-circuit rebreather; (d) inherent risks and hazards related to diving in a hyperbaric environment, including, but not limited to: decompression sickness, barotrauma including arterial gas embolism, hyperoxia, hypoxia, hypercapnia, narcosis, other hyperbaric injuries, drowning, and all other hazards relating to scuba diving including oxygen toxicity. I know full well that by participating in this activity I may be seriously injured or die, even if I do nothing wrong while diving.
- () Yes I understand that all electronic controls, instruments, and breathing loops associated with rebreathers are inherently subject to random and spontaneous failure, and that those subjected to aquatic environments are especially prone to failure. As such, I agree and acknowledge that I will not conduct any dive operations using any closed-circuit rebreather without also carrying the appropriate redundant breathing gas supply, redundant dive computer and/or decompression table that I can use in the event of failure of the breathing loop, my chosen decompression system, or both. I understand that I must continuously monitor the rebreather's electronic controllers to watch for warnings and/or failures in the system, and I agree to do so. I further understand that the sole responsibility for keeping me alive underwater rests with me and not the equipment, and I agree to plan and conduct all my dive operations so they are conducted safely and successfully.
