ORDER TO SHOW CAUSE

THE STATE OF FLORIDA:

TO EACH SHERIFF OF THE STATE:

YOU ARE COMMANDED to serve this order on Defendant, **ROB NETO**, by personal service as provided by law, if possible, or, if you are unable to personally serve Defendant within the time specified, by placing a copy of this order with a copy of the Summons on the claimed property located at **5010 Fort Road, Greenwood, Florida 32443**, at least 5 days before the hearing scheduled below, excluding the day of service and intermediate Saturdays, Sundays, and legal holidays. Non-personal service as provided in this order shall be effective to afford notice to Defendant of this order, but for no other purpose.

Defendant shall show cause before the **Honorable TOBY S. MONACO**, on **July 14, 2015, at 3:00 p.m. in the Alachua County Family and Civil Justice Center, 201 E. University Avenue, Room 416, Gainesville, Florida 32601**, why the property claimed by the Plaintiff in the complaint filed in this action should not be taken from the possession of Defendant and delivered to Plaintiff.

Defendant may file affidavits, appear personally or with an attorney and present testimony at the time of the hearing, or, on a finding by the court pursuant to Section 78.067(2), Florida Statutes

(2014), that Plaintiff is entitled to possession of the property described in the complaint pending final adjudication of the claims of the parties, file with the court a written undertaking executed by a surety approved by the court in an amount equal to the value of the property to stay an order authorizing the delivery of the property to Plaintiff.

If Defendant fails to appear as ordered, Defendant shall be deemed to have waived the right to a hearing. The court may thereupon order the Clerk to issue a Writ of Replevin.


